HOW TO OBSERVE THE MEETING

Telephone: Telephone: Listen to the meeting live by calling Zoom at **1-253-215-8782** Enter the Meeting ID# 998 977 5651 followed by the pound (#) key. Password for the meeting is **758192**.

Computer or mobile: Watch or listen to the meeting from a computer or mobile device with internet access by navigating to:

HOW TO SUBMIT PUBLIC COMMENTS:

Written / Read Aloud: Please email your comments to dmd1944@gmail.com, write "Public Comment" in the subject line. In the body of the email, include the agenda item number and title, as well as your comments. If you would like your comment to be read aloud at the meeting (not to exceed three minutes at staff's cadence), prominently write "Read Aloud at Meeting" at the top of the email. All comments received before 11:30 AM the day of the meeting will be included in the minutes and provided to the Trustees at the meeting. Comments received after this time will be treated as telephonic/electronic comments.

Telephonic / Electronic Comments: During the meeting, the Board President or designee will announce the opportunity to make public comments and identify the cut off time for submission. A short recess (generally less than 5 minutes) will take place during the time public comment is open to allow the comments to be collected. Please email your comments to dmd1944@gmail.com, write "Public Comment" in the subject line. In the body of the email, include the agenda item number and title, as well as your comments. Once the public comment period is closed, all comments timely received will be read aloud. Comments received after the close of the public comment period will be added to the record after the meeting.
